4. SPECIAL INSTRUCTIONS:

- a) Validity: Offer should be valid for 60 days from the date of opening of tender.
- b) The tenderer should accompanied by an Earnest money @2% of the total value of bid/offer including G.S.T in the form of Pay Order/Bank Draft only from a scheduled Bank made in favour of Chief Meteorologist, Flood Forecasting Division, Lahore. The Earnest Money shall be subject to forfeiture if after opening of the tenders, a tenderer withdraws his offer before the period for which his offer is valid. The offer with insufficient Earnest Money or without Earnest Money will be rejected straight away.
- c) In case of placement of contract on the Tenderer / Firm 2% Earnest Money will be converted into Security Deposit, and firm will deposit the remaining 3% amount of security deposit, required other than Earnest Money amount available with department within 5 days, time failing which the Earnest Money will be forfeited and risk purchase effected at the cost of such defaulting firm.
- d) Black listed firms in any Government or Semi-Government or in private sector are not allowed to participate in bid.
