2. It has been reported that copy of this letter was found posted on one website (propakistani.pk) on 15<sup>th</sup> November, 2019.

3. On scrutiny it has been found that copy of this Ministry's letter was placed on a website bearing receipt stamp of a Federal Division. This implies that it was leaked one way or the other from there. Posting of classified letter on open source is a matter of concern that merits attention so as to avoid its reoccurrence in future.

4. It is requested that necessary control measures may be put in place to secure secrecy of sensitive Advisory issued by this Ministry relating to IT and cyber security on the basis of credible reports and input.
