**Subject: FURTHER LIBERALIZATION OF LIBERALIZED PENSION RULES
FOR CIVIL SERVANTS-FAMILY PENSION.**

In terms of Finance Division (Regulations Wing) letter No. 1(13)-Reg.6/83 dated 23.10.1983, family pension is authorized to the eligible family member of the deceased employee. It may be noted that succession certificate is not a requirement for finalization of family pension. However, it has been observed that departments demand succession certificate from the pensioners for preparation of family pension cases thus resulting undue hardships to the pensioners. Therefore, it is requested that a circular may be issued to all Ministries/Divisions/Departments to forward complete family pension cases to this office for finalization without succession certificate from the courts. However, other required documents are to be furnished.
